- 1. Describe the proposed new degree program, including the following:
 - A brief description of the program and a statement of objectives including the student learning outcomes and how the learning outcomes will be assessed;

The Master in Urban Design program (MUD) is an advanced, interdisciplinary program of study for graduate students with previous degrees in architecture, landscape architecture, and city planning or the equivalent in professional design experience. Through a 3-semester (summer, fall, spring), 36 graduate credit workshop focused course of study, students engage directly in a community of inquiry, learning, and practice to examine contemporary challenges facing

urbanized regions. Students learn to work across boundaries and scales using the process of design to make sense of human settlements and the complex systems that shape them, creating more adaptable, flexible, and ecologically sustainable urban places within the dynamic context of an ever changing world.

Key Learning outcomes:

Gain awareness of professional knowledge and integration of new practices, technologies and methods of urban planning and design.

Learn the ability to engage in advanced thinking skills integrating concepts, ideas and approaches in a team-based, interdisciplinary design process.

Acquire new knowledge and skills in urban design that support professional leadership in the development of research and design work focused on local and global issues facing the contemporary city.

Assessment:

The nature of studio pedagogy results in constant observation and evaluation of student work (outcomes) by a broad sector of the faculty and visiting professionals via public reviews and exhibitions of that work. Students consistently are involved in assessment of their learning through reflection and self-critique of this same work. As such, the assessment of student outcomes is an extension of the studio pedagogy of the college. Assessment that occurs in concert with strategic planning and catalog revisions and by departmental advisory boards provides additional layers of informal review to stimulate positive change.

For this new degree program additional and specially targeted assessment strategies will be developed. Students learning will be assessed through a combination of 4 different methods:

- 1. The College of Design student course evaluation system with a supplementary set of questions that target this new degree program more specifically. The standard set of questions will be used along with the supplementary set developed by the program director and associated faculty.
- 2. A student entry/exit survey instrument developed by the College.
- 3. A faculty review at the end of every semester. This review will include a survey and formal discussion of student work coordinated by the program director and including all program faculty. Documentation of this review will include a record of student work along with comments, discussion, and recommendations for program modification.
- 4. An alumni survey instrument that will be developed to track students in the work place at least 2 and 6 six years after graduation. This survey will assess and analyze employment statistics, professional accomplishments, and significant contributions to the field such as publications, realized projects and public recognition.

The program director and faculty, under the leadership of the Associate Dean for Academic Programs, will review the data from all methods comprehensively every 2 years and make formal recommendations for modifications to courses and curriculum.

b. The relationship of the proposed new program to the institutional mission and how the program fits into the institution's, college's, and department/program's strategic plan;

Urban design is increasingly becoming a design field that can mediate between individual architectural and landscape projects and overall planning strategies. It is both a research and practice based field seeking new ways and new technologies to help cities develop in more sustainable ways. The College of Design has a long tradition in design-based research and outreach and a Master of Urban Design degree supports the college's mission of interdisciplinary research and scholarship while providing a resource for the university, the community and the state. In addition, the College of Design's current 2010-2015 Strategic Plan focuses on the continuing development of both graduate programs and faculty research. Retention of a research-based master's degree program in Urban Design is critical to the college reaching its goals. The proposed master's degree advances the more recent amendments to the College of Design's basic strategic plan and the following emerging themes:

- A refreshed dedication to graduate education and advanced study within the college.
- Increased support for faculty.
- A commitment to diversity as a defining characteristic of the collegiate community.
- A continued preoccupation with the development of interlocking centers of interest within its pedagogy and intellectual pursuits.
- A development of global venues for the extension of our academic community.

The Master's of Urban Design is also directly related to the content and structure of the 2010-2015 lowa State University Plan, entitled "Meeting the Challenges of the 21st Century. Therefore, in support of the larger university mission and vision, and in furtherance of its own founding charter, this proposed degree has adopted the following **aspirations:**

- To create distinguished urban design scholarship by promoting discovery and innovation within its cross-disciplinary concentration and advanced study.
- To share the urban design scholarship and practice to enhance the learning opportunities for the university community, professional constituencies, alumni and consumers of design everywhere.
- To apply urban design knowledge with its many constituents, enriching the intellectual environment of the university community, and improving the visual and experiential environment of state, national and global communities by addressing the interwoven issues of social and economic development, environmental stewardship, community design, preservation and growth.

c. The relationship of the proposed new program to other existing programs at the institution; describe how the proposed program will enhance other programs at the university.

The M.U.D. program draws strongly on the College of Design's architecture, landscape architecture, and planning faculty research and teaching expertise and intellectual ethos as demonstrated in current studio and seminar offering. The positioning of the M.U.D. as a college research-based degree for students with an undergraduate design degree should aid in the development of increased interdisciplinary study and other proposed master degree in the College of Design currently being discussed. The M.U.D. is a logical next step, reflecting the increasing interdisciplinary focus of the design fields and design practice. A M.U.D. would be appealing to professionals in the design disciplines who have a singular, accredited bachelor's degree in one discipline, as they could use their existing knowledge to leapfrog into advanced study in a related field. The M.U.D. program supplements related disciplinary courses across the University in departments such as History, Environmental Studies, Horticulture, Natural Resource Ecology and Management, Political Science and Sociology (a list of course is provided as supplemental material).

d. The relationship of the proposed new program to existing programs at other colleges and universities in Iowa, including how the proposed program is different or has a different emphasis than the existing programs; and

The Urban and Regional Planning program at the University of Iowa has been offering graduate education in urban and regional planning. Its areas of concentration include: economic development; geographic information systems (GIS); land use and environmental planning; housing and community

development; and transportation. Its focus is a regional scale and on planning, and specifically analytical urban planning, public policy, and sustainability.

The proposed Masters of Urban Design degree seeks to integrate the design process into the framework and understanding of global and local urban environments in order to create more sustainable and healthy cities.

e. Special features or conditions that make the institution a desirable, unique, or appropriate place to initiate such a degree program.

The new degree program combines academic and professional experience and expertise of faculty from the Architecture, Art and Design, Community Regional Planning, Graphic Design, Interior Design and Landscape Architecture in the College of Design (a list of current course offerings for the above programs is included as supplemental information). Each of these nationally recognized programs have numerous graduates employed throughout the United States and the world. The proposed Masters of Urban Design degree program is desirable because of the global employment of Iowa State University alumni and the fact that the Architecture and Landscape Architecture Programs are unique professional program offerings among all public and private institutions in the State of Iowa.

f. Does the proposing institution have personnel, facilities, and equipment adequate to establish and maintain a high quality program?

The College of Design has facilities and personnel resources required to establish the proposed Masters of Urban Design degree program. Course content does exist in many of the existing academic programs and can be utilized in the new degree program as elective offerings. New courses will need to be developed incorporating current faculty expertise and research as well as consulting with professional practitioners in the expanding area of urban design as well as in the areas of architecture, landscape architecture and community regional planning.

- g. How does student demand for the proposed program justify its development?

 The Masters of Urban Design degree has been developed to draw from designers with a professional design degree, such as, architects, landscape architects, graphic designers, artists, and interior designers, who wish to specialize in a more intellectual/interdisciplinary oriented aspect of urban design. The emerging role of transdisciplinary design is likely to provide a wide audience from a variety of backgrounds for the Master of Urban Design degree.
- 2. Describe the state and/or national workforce need and/or demand for graduates of the proposed program currently and in the near future (provide documentation about the sources of data used to estimate need and demand.)

We anticipate demand to remain steady or grow, based on predictions by government sources. According to the U.S. Department of Labor Bureau of Labor Statistics, in their Occupational Outlook Handbook, 2010-11 Edition, employment of urban designers will increase at approximately 19 percent over the next decade, between 2008 and 2018. This rate is slightly higher than for architects, whose employment is projected to increase at about 16% and is slightly lower than for landscape architects, whose employment is projected to increase at about 20% (ftp://ftp.bls.gov/pub/special.requests/ep/ind-

occ.matrix/occ_pdf/occ_17-1012.pdf; and /occ_17-1011.pdf). Report also notes that this rate of growth is faster than the average rate of growth for all occupations. The rate at which cities grow is increasing, and recent press has profiled the urban design profession as a sustainable approach to design, which may increase its appeal to students seeking degree programs. For example, the December 2009 issue of U.S. News and World Report ranked urban design as one of the fifty best careers in 2010 offering strong outlook and high satisfaction in both the private and public sectors.

c. What are the anticipated sources of these students?

We anticipate three primary sources for the proposed Master of Urban Design degree: 1) Current undergraduate students in design programs who want to target their career paths toward urban design. 2) Undergraduate students at

other institutions who are interested in a more specialized study in urban design, 3) Mid-career professionals with a design degree who are looking to transition from their current design practice, such as architecture, graphic design, interior design, or landscape architecture, to urban design.

5. If there are plans to offer the program away from the campus, briefly describe these plans, including potential sites and possible methods of delivery instruction.

The Rome program. The Rome program is the College of Design's flagship international program — the only fully-licensed study-abroad program in the lowa regents' university system. The urban setting of the studio and its proximity to other major European academic centers that engage contemporary urban design issues make this program viable for offering students active discourse and hands-on projects confronting the exploding metropolis. The summer program led by the landscape architecture department, in particular, has offered an intense two-month urban design studio and supplementary urban theory class. This program can expand and further develop to accommodate the proposed master program.

Summer Academy Berlin. In collaboration with faculty and students from Germany and other U.S. architecture programs, the Summer Academy Berlin explores the possibility of designing sustainable urban environments. Because of construction needs after the reunification of Germany, Berlin has become a field laboratory for energy-efficient design in many new residential, commercial and government buildings. This intense design program, which is held in collaboration with the Polytechnic Berlin, investigates technical requirements and architectural opportunities.

There is also opportunity to collaborate with universities in China, Mexico and Turkey where Iowa State University and the College of Design have student exchange programs and agreements. We are not sure the outcome of this collaboration, however, we as a committee feel that given today's use of technology and global issues facing design and cities, the opportunity to collaborate with these universities is desirable and appropriate for the proposed degree program.

Given the number of courses in this curriculum that already exist, and the interdisciplinary nature of the proposed Masters of Urban Design degree program allows us to draw from the full range of expertise in design that already exists within the College of Design. This includes professors and lecturers with years of academic scholarship and active research in the areas of architecture, planning, landscape architecture, as well as industrial, graphic, and interior design, digital media and the studio arts. In addition, the participating faculty will include those with expertise in design history and criticism. The participating professors from the College of Design have a long tradition of working with students outside of their design disciplines, so they will be ideally qualified for the interdisciplinary students and program emphasis.

Facilities within the College of Design can accommodate both studio and seminar learning experiences; the college offers state-of-the-art technology, model shop, gallery exhibitions, the Design Reading Room, and a comprehensive Visual Resource Collection, which is constantly expanding. In addition to the on-campus facilities, the College of Design maintains a teaching facility in Rome, which is available for short term workshops.

Summer term

Foundation of Urban Design Workshops (9 credits)

The Urban Design Foundation Workshop is an intense module workshop intended to introduce necessary skills and base of knowledge to carry students through their studies in the M.U.D. program. The workshop is organized using 3 modules at 3 weeks each focused on media, theory, and methods.

Foundation of Urban Design Media Workshop (3 credits)
Utilizing various digital and analog methods for representing the urban
environment, this course explores a range of graphic techniques and analytical
methods used in urban design and related design methodology

Foundation of Urban Design Theory Workshop (3 credits)

This course introduces different theoretical approaches to urban design, using both historical and contemporary examples such as public space, policy and regulations, and environmental issues and concerns.

Foundation of Urban Design Method Workshop (3 credits)

This course serves as a workshop to introduce research, analysis and topics related to urban design methodologies. Students focus on a range of issues in the study of urban design and develop an understanding of research as it relates to the field.

Fall Term

Urban Design Studio I (6 credits)

This course combines analysis and observation of urban morphology and culture with urban design projects set in local cities of the United States. Its goal is to provide students with the skills to observe and interpret urbanism as they develop processes for designing cities concerned for both physical form, ecological principles and human activity. The studio also seeks to enable designers to communicate their ideas through different scales, graphic and verbal means, to understand compelling outcomes of the urban design process. Students look at the city, the district and the neighborhood scale and examine the importance of place making in an urban setting.

Theory of Urban Design (3 credits)

The purpose of this course is to critically evaluate the beliefs and practices of urban design including the relation of the built environment to the natural environment, the use and meaning of public places, and the relation of technology to land use and community. Students explore what past generations have written about the design of cities and compare the new challenges written about the contemporary city of this generation. Key to interpreting urban theory is an understanding of how different philosophies shape form, configuration and distribution of uses. Topics include historical moments and movements in urban design, modern planning and design, contemporary urban design practice and future urban theory and methodologies.

History of Urban Form (3 credits)

The course offers a study of the historical development of the physical form of western cities from ancient times to the present. The course examines European and North American cities under the following themes: Ancient and Classic, Medieval, Renaissance and Baroque, and Modern (nineteenth and twentieth centuries). The course will include where possible and applicable an examination of cities in Asia, Africa and Latin America.

Spring Term

<u>Urban Design Studio II (6 credits)</u>

This studio focuses on one or two projects related to emergent urban zones such as, economic, tourism, informal settlements, hidden enclaves, and post-industrial zones as they relate to the global city. The studio is coordinated with the seminar, Methodologies in Urban Design, where research subjects and term products are related to the studio's projects. Students complete the studio with the aptitude to design projects and to create the implementation strategies and reports to defend their designs.

Methodologies of Urban Design (3 credits)

This seminar focuses on professional and research techniques in the practice of urban design. Students will examine case study examples and research contemporary urban design topics. The emphasis on professional techniques involves examining issues related to communication, representation, roles of the designer, the design process and ethics. The course will examine research methods associated with measuring, analyzing and guiding design in urban contexts such as environmental behavior and psychology, morphology, design regulation and policy.

The M.U.D. degree is a coursework only program of study.

There would be considerable benefits to the College of Design academic programs in terms of enrollment and interdisciplinary discourse. Anticipated coursework could also provide university graduate courses for other graduate colleges.

4. Mission and Name

4.1 Mission. As part of its strategic planning and proposed reorganization, a new mission statement for the College may need to be crafted. While the actual mission will need to be discussed and finalized, the current mission statement should be used as a starting point: The College of Design cares about the conditions in which humans live, regardless of economic, social, and cultural backgrounds, and strives to improve the quality of life for everyone.

- *4.2 Core Values.* Core values in support of that mission include:
 - A commitment to the land-grant mission of Iowa State University and to the people of the State of Iowa.
 - A sense of academic and professional community that manifests itself every time there is an opportunity.
 - Collaboration within and outside the college.
 - Appreciation of multiple cultures and diversity.
 - Interdisciplinary teaching, research, and outreach.
 - Pride in the professional competency of our students and their abilities.

5. Administrative Organization and Implementation

5.1 Description of the College. The reorganization of the College of Design will enhance both its component disciplines and the College as a whole in order to reinforce shared values and aspirations as well as goals for the future. Since the department is the basic administrative unit within the university, this plan reorganizes the College into seven departments:

- Architecture
- Community and Regional Planning
- Graphic Design
- Industrial Design
- Integrated Studio Arts
- Interior Design
- Landscape Architecture

The seven departments will make the College of Design a center of creativity that values collaboration and is engaged with multiple constituencies. It will enhance the capacity and talent of the faculty and focus on core expertise in design, as well as increase recognition by other units across the university that design is critical for their activities. It will enable the College to intensify its focus on research and graduate education and promote itself as a holistic unit. In addition, the departments' collaboration will be encouraged by existing infrastructure, including the King Pavilion, an environment that fosters cross-disciplinary cooperation, as well as resources in the main building.

5.2 Dean's Office

(A diagram of the proposed organizational structure can be found in Appendix 6.4.)

5.3 Departments. The College will consist of seven departments:

- Architecture
- Community and Regional Planning
- Graphic Design
- Industrial Design
- Integrated Studio Arts (includes the areas of Integrated Studio Arts, Art History, Biological and Premedical Illustration, and Art Education)
- Interior Design
- Landscape Architecture

The term department is a widely recognized term within the university and beyond and departments are "the basic administrative unit within the university. It includes all staff members engaged in teaching, research, and extension activities related to that particular academic discipline. All members of the faculty are affiliated with at least one academic department. All tenured faculty hold tenure in a department (ISU Faculty Handbook Section 2.5). Thus all members of the faculty in the College of Design will be affiliated with an academic department and the seven departments will be the tenure home(s) for College of Design faculty.

Although the seven departments will collaborate and enrich each other, each department will remain in charge of their curriculum, promotion and tenure, and hiring. The seven departments will also be represented on Academic Affairs, Faculty Development, and Liaison Councils. In addition, according to Article II, Section 5 of the *Faculty Senate Constitution*: "Each department is entitled to one senator elected by the faculty of the department." To that end each department will need to develop a Governance Document that includes information specific to their mission and governance domains, as well as policies and procedures of operation; it should parallel the type of information contained within the College's Governance Document.

While some of the other councils and boards may be eliminated, combined, or restructured, College of Design faculty and students may be best served by partnerships between departments with common interests or "at-large" membership on some decision-making bodies, rather than requiring every department to be represented on all committees as had been the case previously.

Toward that end, the Liaison Council will initiate a Committee-on-Committees to review all college committees and make a recommendation by Spring 2012 to the faculty and staff concerning college committees.

5.4 Department Chairs. Each of the seven departments will be directed by a Chair. The Chair will be the chief academic officer of the department and will report to the Dean. The Chair is responsible for leading the overall work of the department in the areas of teaching, research, and service; preparing and administering the departmental budget; and

recommending personnel actions and merit salary recommendations. The Chair will also be responsible for the overall academic supervision of the department's students, as well as recruiting quality faculty and students, facilitating faculty development, developing and implementing quality academic programs, and advancing departmental resources and program quality.

5.5 Faculty. All faculty will hold their academic appointments in departments ("home department"). All matters of tenure and promotion will be decided according to the rules and procedures of the home department. Faculty members also may be identified with an interdisciplinary program. In such cases, the terms of the interdisciplinary appointment and its effect on the faculty member's responsibilities in the home department will be clearly outlined in the faculty member's PRS. The PRS, and any subsequent revisions to it, will be agreed upon by the faculty member, the department chair of their home department, and, when appropriate given the nature of the appointment, the director of the interdisciplinary program with which the faculty member is identified. Any change to the faculty member's responsibilities in their home department or interdisciplinary program will be reflected in a revised PRS. A department chair will be responsible for annual reviews and the promotion and tenure process. However, when the appointment includes participation in an interdisciplinary program, the interdisciplinary program director will be expected to contribute their assessment of faculty performance related to that program to the home department chair.

5.6 Promotion and Tenure Guidelines. In addition, the Liaison Council will request the Faculty Development Council to examine and propose a promotion and tenure process for faculty involved with interdisciplinary programs by Spring 2012. These policies and processes should be similar to and consistent with those processes already established in the departments, the College, and the university. In the meantime current Promotion and Tenure (P&T) policies will remain in place through spring 2018 for faculty already affiliated with the College of Design. Those faculty will have the option to utilize either the former or the newly established criteria during the transition period. Full transition to the new P&T Guidelines will be fully accomplished by Spring 2018. Any new faculty hired by the college after the approval of the reorganization plan will follow the new P&T Guidelines.

5.7 Interdisciplinary Program Directors. There are precedents to inform the organization of multidisciplinary programs at ISU. Most intercollegiate, multidisciplinary programs are administered directly by the Graduate College, have an identified faculty group that is responsible for establishing the curriculum, and have faculty that hold their academic appointments in "home" departments. In the case of these graduate intercollegiate programs, governance is typically by a defined faculty and a faculty chair or director, who typically reports to the Graduate College. The Graduate College's Graduate Council serves in an advisory capacity to the Dean of the Graduate College, approves new graduate programs, and establishes educational policies that govern graduate education throughout the College.

However, it should be noted that the College of Design has a long history of engaging in interdisciplinary programs. Part of our efforts with this reorganization focus on formalizing some of our existing programs (such as the common undergraduate first-year CORE program) and some new degree programs that have previously been administered under the umbrella of Design Studies. Under this organizational arrangement these programs were without standing with regard to hiring, curriculum development, or representation in shared governance. Within this reorganization process efforts have been made to formalize their standing with regard to curriculum development, resource allocation, and shared governance while enhancing their visibility within the College.

Borrowing somewhat from the model used by the university in the graduate college and based upon the College's history and intensions, it is proposed that each interdisciplinary program and degree in the College of Design will have a Director who is responsible for leading the overall work of the program in the areas of teaching, research and service; preparing and administering the program's budget; providing input on faculty hires and student and faculty recruitment; and leading faculty development including faculty reviews. The Director will be the main point of contact for students in the program and those seeking information about the program. Directors will have authority to initiate all transactions necessary to compensate and incentivize departments for their participation in the delivery of the curriculum, and will administer the budget associated with these transactions.

5.8 Interdisciplinary Program and Degrees and Affiliated Faculty. All interdisciplinary programs and degrees will have an identified faculty group that is responsible for establishing, advancing, and implementing the curriculum. The Director, in collaboration with this faculty group, will manage the resources allocated to that program for scholarship and faculty incentives.

5.9 Curriculum Development. The Liaison Council will request that the Academic Affairs Council examine and propose a curriculum review and approval process for interdisciplinary programs by Spring 2012. These policies and processes should be similar to, and consistent with, those already established in the college.

5.10 Policies and Procedures for Interdisciplinary Faculty and Students. The Liaison Council has requested the Design Caucus and the Student Affairs Council review policies and procedures and suggest any additions or modifications that may be necessary to accommodate and protect faculty and students affiliated with interdisciplinary programs by Spring 2012.

5.11 Scholarship, Research, Outreach & Creative Activities. Created in 1993, the Institute for Design Research and Outreach (IDRO) encompasses the research, extension, distance education, and outreach functions of the College of Design, working with outside organizations to address real-world problems and develop initiatives.

The College, with its new administrative structure, will be in a position to enhance its national leadership in all areas of scholarship, research, outreach, and creative activity. IDRO, as well as the efforts of faculty, staff, and students, both individually and in collaboration, will enable the College to continue to focus on scholarship that integrates design with problem solving as well as creative artistic expressions.

The Liaison Council will request the formation of a Review committee that in partnership with IDRO will assess its structure and operations and make recommendations concerning how those might be improved to support the College's research, outreach, and extension activities. The Review committee will also work with IDRO to create a plan for developing the necessary resources and personnel to support research within the College of Design by Fall 2012.

5.12 Governance. The Liaison Council will request the establishment of an ad hoc Governance Committee to examine and draft a new Governance Document for the College by Fall 2012. The governance document describes the college's mission, governance domains, governance structure, and other policies and procedures.



Lastly, two years after this plan has been implemented in full, it is the intent of the Liaison Council to revisit the results of this reorganization to identify what aspects are working well and to recommend changes in order to improve the structure and administration of the College of Design.

The Master of Urban Design degree proposal is part of new interdisciplinary academic initiatives in the College of Design. The degree builds on existing faculty expertise in the College of Design. Courses on urban design are offered in the different professional programs, mainly in Landscape Architecture, Community and Regional Planning and Architecture, in addition to a few in Graphic Design and Integrated Studio Arts. In that sense, the degree consolidates faculty expertise in these programs and help coordinate courses across departments to provide an integrated graduate education on urban design.

Being a post-professional degree, this degree proposal provides an academic opportunity for practicing professionals in architecture, landscape arch., planning and others to update and expand their practice. The possibility of finishing the degree in one calendar year makes it more plausible for such professionals to enroll. Expanding the College of Design offerings for professional practitioners will enlarge and diversify the graduate population in the college and create a stronger interface with the various professions.

Similar to other interdisciplinary degrees proposed by the college, the Master of Urban Design introduces integrated professional practice, i.e. includes multiple professional fields, as a new form of advanced professional education. Moreover, the proposal expands the scope of urban design to include regional and global scales, which will prepare students to understand design practice in relationship to contemporary forces of globalization and integrated world economy. These factors will set the College of Design at Iowa State University apart from other design schools in producing innovative models of integrated urban design practices in the future.

Finally, once implemented, this degree will reinforce areas of academic growth for graduate education in the College of Design by expanding the scope of graduate course offerings for current students and providing new opportunities for applied design research for faculty.
