VI. New Business

A. Classroom Disruption Policy - [S02-17]

Sanjeev Agarwal presented a draft of a classroom dismissal policy that had been prepared by the Academic Affairs council. A lengthy discussion followed centering on a few key points. How is disruption to be defined? What is the role of the department chair in reviewing/approving a request to remove a student? What are the consequences to a student who is removed? How is removal to be reported on the transcript? What are the avenues for appeal by the student (if dismissed) by the instructor (if dismissal is denied).

B. College of Business Admissions Policy - [S02-18]

Sanjeev Agarwal presented a proposed new admissions policy or the College of Business. The main point was the introduction of a requirement for students not majoring in Business to meet the same standards as those admitted into the program if they wish to take more than 9 cr of upper level (300+) business courses. The College desires this to deal with students who are denied admission but who attempt to take business courses. The concern is that if they are not prepared and do not meet the standards expected of business students they should not be taking up seats in highly desired, oversubscribed courses. As well, students who are not prepared can have a negative impact on the level of the course.
